- NO GLASS ALLOWED ON THE BEACH OR GRASSY AREA.
- NO PETS ALLOWED ON THE BEACH.
- NO PERSONAL GRILLS ALLOWED ON THE BEACH.
- ❖ PLEASE PLACE ALL OF YOUR TRASH IN THE TRASHCANS.
- CA MEMBERS MUST ACCOMPANY & STAY WITH THEIR GUESTS. YOU ARE ALLOWED TO HAVE 4 GUESTS PER CA CARD AT THE: POOL/BEACH/GOLF/ TENNIS. GUESTS MUST STILL PAY THE DAILY FEE FOR POOL OR GOLF.
