- OUTSIDE FOOD AND NON-ALCOHOLIC BEVERAGES ARE ALLOWED AT ALL PAVILIONS.
- OUTSIDE ALCOHOL IS ALLOWED AT JEFFERSON POINT & MAIN MARINA PAVILIONS. THE CLUBHOUSE PAVILION FALLS UNDER THE CA CLUBHOUSE LIQOUR LICENSE AND DOES NOT PERMIT OUTSIDE ALCOHOL.
- NO BONFIRES OR FIRES OF ANY KIND ARE ALLOWED ON THE BEACHES.
- ❖ OUTSIDE MUSIC MUST CEASE BY 10:00PM.
- RENTAL OF A PAVILION MEANS YOU HAVE THE PAVILION ONLY RESERVED. THE PARKING LOT, BEACH, GRASSY AREA, AND RESTROOMS ARE STILL AVAILABLE TO CA MEMBERS DURING YOUR RENTAL TIMES.
- ❖ PLEASE PLACE ALL OF YOUR TRASH IN THE TRASHCANS.
- NO GLASS ALLOWED ON THE BEACH OR GRASSY AREA.
- NO PETS ALLOWED ON THE BEACH.
- ❖ CHARCOAL GRILL IS AVAILABLE AT THE PAVILION.
- NO SPECIAL SET-UPS: PICNIC TABLES ARE IN PLACE AS IS.
- ❖ CA MEMBERS ARE ALLOWED TO HAVE 12 GUESTS PER CA CARD AT THE BEACH BUT MUST REMAIN WITH THEM.
- ❖ YOU MUST NOTIFY THE LSLCA EVENT COORDINATOR IN ADVANCE OF ANY OUTSIDE VENDORS WHO WILL BE AT YOUR EVENT. (EX. BAND, PETTING ZOO, BOUNCE HOUSES, FOOD TRUCKS, ETC).
