**** CA REMINDERS ****

DREDGING: Magruder will be dredging in Dauphine through the end of April. Please do NOT enter Dauphine Cove during dredging operations. Lakefront homeowners should use NO Wake zones to enter and exit the cove.

BOATING SAFETY COURSES: Please contact Water Patrol to schedule a date and time: 636-625-3120. This is a One time course– if you have taken our class there is no need to take it again. If your not sure please call .

Annual Assessments: The LSLCA Annual Assessments were due March 1st, unpaid member accounts will receive a \$50 Late Fee in April. You can pay online, in person or mail a check. Credit/Debit card transactions on Assessment payments will have a 2.75% convenience fee. If you are paying online, we now offer an ACH payment option with no additional fees (on Assessment payments only).

Online Boat Registration Payments: If you are paying for your 2021 Boat Registration online, you will pick up your Boat Registration Stickers from the Water Patrol Office (located at Main Marina). **You will need to bring your required documents to receive your stickers.** There could be a 3-business day delay before Water Patrol has your stickers. Please call first!!

APRIL 1st DEADLINES:

All CA Rental Docks MUST be paid by April 1st. Anyone who has not paid their Rental Dock Fee, will lose the dock. **NO EXCEPTIONS.**

2021 Boat Stickers must be displayed on your boat by April 1st if your boat is on or above (on a lift) the water. Failure to display stickers for those boats on or above the water by April 15th will result in a first violation of \$100. Failure to display by May 1st (and subsequent months) will result in a 30 day suspension each subsequent time the boat is not stickered. If you can not put your sticker on your boat, please contact Water Patrol for assistance.

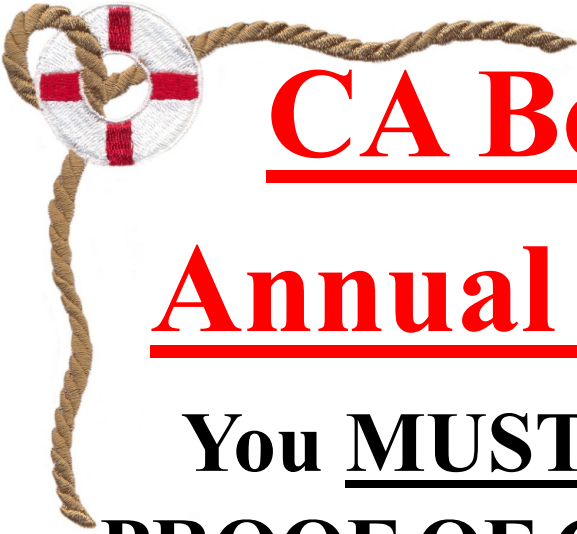

CA Boat Registration

Annual Requirement

You **MUST** have this with you
**PROOF OF CURRENT OWNER-
SHIP:**

- * **Original Boat Title(s)**
- * **Original Motor Title(s) (OB-
only)**
- * **Proof of Current Insurance**

(for boat(S) & motor(S) (ob only)

We will NOT accept Property Tax Receipts, Annual State Registration,
Application for Title over 30 days old, & we will NOT accept Copies of Titles

Also, for a Newly Obtained Boat or Class 8:

- * **WATER PATROL INSPECTION FORM-
WITHOUT THIS PAPERWORK YOU
CANNOT REGISTER YOUR BOAT**
