**CA REMINDERS **

Class 8 Boats -On January 22, 2019, a motion was made by the LSLCA BOD stating; only Class 8 boats that were registered in 2018 will be allowed on the LSLCA large lake (after re-inspection and registration). No other class 8 boats will be allowed or authorized for use on the LSLCA lake.

Due to concerns voiced by some CA Members, a moratorium was put in place regarding Class 8 boats and Wake Surfing and will be discussed at the next L&P & BOD meetings in February. Lakes and Parks meets on Feb. 5th and BOD meets on Feb. 26th.

Lakewood Park Update PWSD2 and the City of O'Fallon will not complete the new lift station until December 2019. The LSLCA will not be able to begin renovations on the park until 2020.

BOATING SAFTEY COURSE- REMINDER: All class 5-8 Boat owners MUST have taken the Boating Safety Course before they can register their Class 5-8 Boat for the 2019 Boating Season. All class 2-4 Boat owners MUST complete the class before they can register for the 2020 Boating Season. ALL Class 8 boats MUST be re-inspected by Water Patrol prior to registering their boat for the 2019 Boating Season. If you still need to take the class, contact **Water Patrol @ 636-625-3120** to register for a class. We offer the class every month and it takes 1 hour.

REMINDER 2019 ANNUAL ASSESSMENTS - If you would like to pay online, go to LSLCA.COM and login. Your MEMBER NUMBER to log in is your CUSTOMER NO: located in the upper right corner of your statement. If you have not logged in previously, your password will also be your CUSTOMER NO: (login & password must be all CAPS).

When mailing in your assessment payment, please put your Customer # (located in the upper right corner of your statement) on your check .

C.A. CARDS ARE YOUR FOREVER CARDS -You do not have to come in and get a new one every year. Once you have paid your 2019 assessments your card will be reactivated.

If your card is lost, there is a \$10 fee to replace it. We are getting into the busy season at the LSLCA office which means we are taking care of the Members that come into the office.
