**BOATING REGISTRATION REMINDER** \*\* Before you can register your boat for the 2020 season, you MUST show proof of ownership by supplying us with your original title (or current tax receipt or registration) and proof of insurance. If paying your registration online, please email your information to <u>frontdesk@lslca.com</u>. Also, ALL CLASS 8 BOATS need an annual inspection by Water Patrol prior to your 2020 boat registration. **DON'T LOSE YOUR DOCK! Your 2020 Dock Rental Fee MUST be paid by April 1st !** 

**"Effective in 2020**, each private Golf Cart used on the Golf Course will require an annual inspection by a Golf Shack employee and an annual registration fee of \$25.00 paid at the time of the inspection. At the time you pay the \$25.00 fee, a sticker will be given to you that you MUST display on your private Golf Cart confirming you have had your annual inspection and paid your annual Golf Cart fee. You will only be allowed to use your private golf cart on the Golf Course if you have your annual Golf Cart sticker displayed.
