BOATING SAFETY COURSES: Offered **VIRTUALLY**. Please contact Water Patrol to schedule a date and time: 636-625-3120.

BOAT REGISTRATION REMINDERS: You will need to bring your boat title(s), motor title(s), (outboard motors-only), and proof of insurance with you to the CA Office when you register your boat for the 2021 boating season. If you pay your boat registration fee online, you will pick up your stickers at the Water Patrol office (located at the Main Marina) where they will copy your original boat title(s), original motor title(s), (outboard motors-only), and your boat Insurance information. You MUST bring your title(s) and proof of insurance to receive your Boat stickers for the 2021 boating season.

WATER PATROL HOURS: January 1^{st} – March 14^{th} 10:00 am – 5:00 pm OR call the Water Patrol office to schedule an appointment.

ASSESSMENTS:

Assessment statements for 2021 were mailed out the third week in December.

Annual assessments are not due until March 1. You can make installment payments, pay online, in person, or mail a check. Credit card transactions on assessment payments will have a 2.75% convenience fee. If you are paying online, we are now offering an ACH payment option that does not have a fee.

Annual Assessments are due on March 1st 2021. Boating Registration & Dock Fees are due on April 1st 2021. If your Dock Fees are not paid by

April 1st you will lose your dock.

ACC approval is required for painting your house, new siding and roofs,

new entry & garage doors, new construction, room additions, decks or any projects that alter the exterior appearance of your home.
