**BOATING SAFETY COURSES:** Offered **VIRTUALLY** . Please contact Water Patrol to schedule a date and time: 636-625-3120.

**BOAT REGISTRATION REMINDERS:** You will need to bring your boat title(s), motor title(s), (outboard motors-only), and proof of insurance with you to the CA Office when you register your boat for the 2021 boating season. If you pay your boat registration fee online, you will pick up your stickers at the Water Patrol office (located at the Main Marina) where they will verify your original boat title(s), original motor title(s), (outboard motors-only), and your boat Insurance information. You **MUST** bring your title(s) and proof of insurance to receive your Boat stickers for the 2021 boating season.

**Copies will NOT be accepted.**

**ASSESSMENTS:** **Annual Assessments are due on March 1st 2021. Boat Registration (On Water Only) & Dock Fees are due on April 1st 2021. If your Dock Fees are not paid by April 1st you will lose your dock– No Exceptions. Boats that are on or above the water on this date must have a 2021 Boat sticker displayed by April 1st. Failure to display stickers for those boats on or over the water by April 15th will result in a first violation of \$100.00. Failure to display by May 1st (and subsequent months) will result in a 30-day suspension each subsequent time the boat is not stickered. If you cannot put your sticker on your boat, please contact Water Patrol for assistance.**

You can make installment payments, pay online, in person, or mail a check. Credit card transactions on assessment payments will have a 2.75% convenience fee. If you are paying online, we are now offering an ACH payment option that does not have a fee.
