**Meeting called to order by Tom at 5:33 pm**

Reviewed April 12th, 2026 meeting minutes. Missy motioned to approve the April minutes as written; Melda seconded the motion. The Committee voted unanimously to approve.

**OLD BUSINESS**

- Kid's Free Tennis Day is Saturday May 16<sup>th</sup> 23 kids had signed up, Tom put information flyer on FB pages to promote. Available to non CA members. Tennis Cinco De Mayo was a success!
- Discussed using old tennis roster to send emails to promote tennis adult and kid clinics. Steve C. to get ahold of old tennis emails. Melda uses Group Me in FL to play tennis, she's going to talk with tennis players to see if there's interest in using Group Me to communicate.
- Charter Revision – Board approved our revisions, Art signed the document.
- FB page consolidation – Jessica posted tennis flyers.
- Wind screens – No wind screens by tennis court 1, an email will be sent to Ron.
- Security system on tennis courts – A new swipe card system price is too high to install. Maybe install a camera for security to view the tennis courts from the golf shack. New locks on all but main gate. Security issue with Friday night golf league, kids jumped on course after kicked off then went to another green to harass players. A golf member took pictures of the kids and the car. Tom sent pictures to CA security.
- Monday clinics conflict with swim meets – everyone will have to find parking, we will let Vetta know the situation.
- Blower for tennis courts – purchased and stored in tennis closet at the golf shack, will evaluate where it will be housed at end of summer.

## **NEW BUSINESS**

- The white divider gates at Lakewood courts were removed by maintenance staff. Ron said he will fix the pickleball post on Court 1 this week. The white gates have been returned to pickleball courts.
  - Lakewood gate and parking on grass – on Sat. April 25<sup>th</sup> a security guy from CA checked our car stickers and told us to keep gate closed and to not park in grass. On Sat. May 2<sup>nd</sup> same security guy, Greg came to check on stickers and tell us to not park on grass. Told one member to go home and retrieve her car sticker. Greg and Vinh exchanged words, Greg eventually called John Stone about the situation. Then we all showed Greg our CA cards to prove membership. The problem with not parking in the grass is if we have 10 or more cars then we have to park in grass. Maybe we give security our club schedule so they know when we are playing. Tom and Art to discuss with John Stone.
  - Mixed Doubles tennis tourney, the date is May 23<sup>rd</sup> with rain date of May 24<sup>th</sup>.
  - Need to purchase “No Parking” signs near the golf shack/tennis courts so golf carts do not park in grass/mud area.
  - The CA Board is discussing raising the CA assessment fee with a vote to happen in the fall. The first vote needs a 60% approval from community then another vote can be done in 60 days. There are many projects around the CA but we don’t have the funds to make improvements.
