#### PERSONAL WATER CRAFT DEVICES—NEW MOTION HAS BEEN MADE:

Effective 8/24/2021 the BOD voted to uphold the ban on all PWC Jet Drives and further prohibiting personal swimming aids, self-propelled paddle boards, tubes, rafts, E-Foils, Scuba Jet, Zapata Flyboard, Dive boards, underwater sea scooter and like items. This list is NOT inclusive of all items on the market. No grandfathering of any personal watercraft device will be permitted. Any watercraft that is propelled by any mechanical means other than hands and feet are prohibited.
