#### PERSONAL WATER CRAFT DEVICES—NEW MOTION HAS BEEN MADE:

Effective 8/24/2021 the BOD voted to uphold the ban on all PWC Jet Drives and further prohibiting personal swimming aids, self-propelled paddle boards, tubes, rafts, E-Foils, Scuba Jet, Zapata Flyboard, Dive boards, underwater sea scooter and like items. This list is NOT inclusive of all items on the market. No grandfathering of any personal watercraft device will be permitted.

Any watercraft that is propelled by any mechanical means other than hands and feet are prohibited.

# ALL OUTSIDE CHANGES YOU MAKE TO YOUR HOMES MUST BE APPROVED BY THE ACC BEFORE YOU CAN BEGIN WORK:

This includes new roof replacement, siding, paint, trim, new windows, new garage & entry doors. Even if you paint your home, garage door or entry door, the new colors MUST be approved by the ACC.

A fine of \$100 per month can be assessed, if you do not get ACC approval prior to starting these projects. A fine can also be assessed for NOT maintaining your property in a neat and attractive manner. This includes keeping your yard nicely groomed and your home's exterior properly maintained.
